## PROPOSED SELF FINANCING HOUSING SCHEME

#### Terms & Conditions for Registration and Allotment

- 1 The intending Buyers has applied for the registration of Flats/Plots with full knowledge and subject to all laws, notifications and rules applicable to this area, which have been explained by the company and understood by him/her.
- The intending buyers has fully satisfied himself/herself about the interest and title of the company in the land, understands all limitations and obligations in respect of it and does not have any objection.
- The allotment of the flat/plot/villa/kothi by the company, against the registration of the applicant, shall be done within 9 months from the date of registration and after receiving 50% of B.S.P.
- The registration amount deposited by the applicant shall be adjusted at the time of allotment with the allotment money to be paid by the applicant/allottee (s).
- For preferential situated flats/plots extra charges as applicable will be payable by the intending buyer. It will be allotted subject to availability on first come first serve basis to those who make the payments as per schedule.
- The company shall pay a simple interest @7% p.a. over the deposited amount, if the company is not in position to allot or hand over the flat/plot/villa/kothi to the applicant within the specified period, except due to reasons force majeure.
- In case of cancellation of the registration before or after allotment, 15% & 25% of the total basic sale price will be forfeited respectively. Balance amount will be returned to
  the applicant only after the sale of booked plot/flat or after 180 days from the date of cancellation. In case payment of any installment as may be specified is delayed, then
  the Applicant(s) shall pay interest on the amount due @ 18% p.a.
- Registration is for present/future projects where allotment would be made only after getting NOC approvals, permissions and clearances from related government / competent authorities.
- The company shall have the right to effect suitable and necessary alterations in the plan/layout/Size/location. The area and measurements of Flat/Villas/Kothi/Plot may
  vary at the time of allotment (subject to approval of respective Govt. Authority). The increase or decrease in the size will affect the cost accordingly.
- 10. The intending allottee, if resident outside India, shall be solely responsible to comply with the necessary formalities, as laid down in the FEMA 1999 or other applicable laws including that of remittances of payments (s) for acquisition of property and for submission of any documents/declarations etc. as may be prescribed. In case any such permission is ever refused or subsequently found lacking by statutory authority/company, the amount paid towards booking and further consideration will be returned by the company as per applicable rules without any interest and the allotment shall be cancelled forthwith.
- 11. The applicant will have to take the prior written permission to transfer his/her registration of Flat/Villa/Kothi/Plot, from the company and will have to pay the processing fees as decided by the company from time to time. At present on all subsequent transfer after the first transfer, the company will charge transfer and/or processing fee © 2% of total cost.
- 12. All payments towards the cost of Flat/Villa/Kothi/Plot shall be made in favour of only SHAURYA HOUSING LTD. through Cheque/D.D payable at New Delhi.
- 13. The company reserves its right to cancel the registration/allotment, if the future payments are delayed by two months.

- Delhi court alone shall have jurisdiction in all matters concerning this transaction.
